## **Transient Rules & Regulations**

Welcome to our Campground and enjoy your stay with us. We would like to make your stay with us a pleasant one, so in the interest of all our campers, we ask that you and any of your guests follow our rules and regulations

- 1. PLEASE USE ONLY OUR FIREWOOD TO PROTECT OUR TREES!
- 2. Cutting or trimming trees without permission will result in eviction from park. Cutting, defacing or debarking of trees will not be tolerated.
- 3. Each campsite is allowed a trailer or tent, a dining tent and a small child's tent. Extra tents are NOT allowed.
- 4. Only licensed drivers may drive inside the park. ATV's are not allowed to be drove around the park. If upi have an Electric Vehicle extra charges may apply.
- 5. NO SPEEDING! Speed limit is only 10 km/hr. Please drive carefully watch for children and signs.
- 6. Parking: One car per site. Other vehicles are to be registered and parked in the visitor parking by the office or campground parking lot unless alternate arrangements have been made by Camp Management.
- 7. Your visitors must register at the office and will be charged a fee upon entry to our campground. They must park in the visitors parking by the office. All visitors must arrive during office hours and leave the park by 11:00pm. The number of visitors per site may be limited at the camp's discretion.
- 8. Your children are OUR guests, but YOUR responsibility.
- 9. Alcohol is allowed on your site only and must be in either plastic or aluminum containers to avoid the risk of broken glass. Absolutely no glass containers off your site.
- 10. Our fire pits are for your enjoyment; please do not leave your garbage in them. Campfires are to be supervised at all times and must be kept low and contained. Campfires are to be put out if no one is present.
- 11. Garbage is to be in plastic bags and placed in the dumpster at the back gate. Do NOT place garbage in the blue recycle bins.
- 12. Boat Launch is used at your own risk. Boats must come out of the water every evening unless previous docking arrangements have been made. No one allowed on boat launch after dark.
- 13. No Fishing off of cement area/swimming area of boat launch. No throwing rocks, they are in place on the launch for a reason.
- 14. Bicycles MUST follow the same direction as vehicles. Watch for signs. Bicycles are not to be ridden after dark. Helmets are recommended.
- 15. Swimming in the lake at all times is at your own risk. Children under 18 must be accompanied by an adult at all times. No one allowed on beach after dark.
- 16. Quiet Time is to be observed between 12:00am and 8:00am. We are a radio free zone during this time. Please respect your neighbors with regards to noise and radios, excessive noise will not be tolerated.
- 17. Your pets are your responsibility please have them leashed at all times and clean up after them. Aggressive dogs must wear a muzzle. Do not allow your dog to bark uncontrollably day or night. Pets are not permitted in the rec hall or on the beach or in the swimming area at any time.
- 18. Playground Equipment: Use at your own risk. All children must be supervised by an adult. No one allowed on playground equipment after dark.
- 19. If you require a pump out, notify the office 24 hours before. \$20.00 fee per pump out.
- 20. Check out time is 12:00pm for transient sites and 10:00am for rentals.
- 21. Roth Park Family Campground shall NOT be held responsible for any loss or damage to your trailer, accessories or persons. The facilities are solely for recreational purposes and at the risk of themselves family and guests. Rates may change at the discretion of Camp Management.
